First :

SECOND:

James E Loghry fifty dollars(\$ 50.00)

Ralph E Loghry(two hundred forty fivedollars(\$ 245.00)

Orville E Loghry four hundred dollars (\$ 400.00)

THIRD:

It is my desire that my executor convert all of my property both real and personal into cash before making distribution.

FOURTH:

I nominate and appoint D. E. Lomas the Executor of this my last Will and Testament, and desire that he be absolved from giving bond for his faithful performance as such Executor.
